PREQUALIFICATION DOCUMENTS

The following prequalification documents are required:

- Evidence of Company registration (CAC Certificate, C02, C07)
- Comprehensive Company profile including details of key Professional staff.
- Preceding 3 years signed Audited Accounts / Statement of Accounts (2018, 2019 and 2020).
- Preceding 3 years ended Tax Clearance Certificate (2018, 2019 and 2020).
- Value Added Tax (VAT) Registration Certificate and evidence of VAT remittances.
- Evidence of Compliance with Pension Act, NSITF, ITF and evidence of remittances.
- Evidence of adequate relevant equipment and facilities to execute the project(s) where applicable.
- Evidence of legal capacity to enter into contract. i.e. the company is not a receivership.
- Evidence of financial capability to execute the project(s). This shall include certified statement from a reputable Bank. (Bank reference letter only is not acceptable).
- Verifiable evidence of previous experience i.e. having satisfactorily and successfully carried out similar project(s) within the last five years.
- Evidence of manufacturer's accreditation; Manufacturing Companies MUST submit evidence of relevant manufacturing capability(s), facility(s) and SON or ISO Certificate.
- Test certificate issued by well-known international standard Test Laboratory for Manufacturers of Equipment.
- For OEM/Representative, ONLY EC Certified or KEMA Certified Manufacturer will be accepted. Such Product will be required to be shipped via Europe. (Evidence of EC / KEMA Certification must be attached).
- NEMSA compliance certificate valid till 31st December 2021.
- An Affidavit affirming that none of the Directors of the Company was ever convicted in a Court of Law.

- Evidence of Corporate Social Responsibility (if applicable).
- Evidence of Corporate Environmental and Governance Policy (if applicable).
- Any other relevant document(s) that will place the company on a comparative advantage.

Interested Contractors who qualify for any or all the categories may apply for Pre-qualification.

Those who meet the criteria above will be prequalified for the categories applied for and will form the list of prospective bidders who will be issued tender documents to bid for execution of project(s) and procurement of goods under relevant categories.
